The places you live, learn, work, experience, and encounter are designed to provide you with academic and extracurricular activities that challenge you and facilitate your success. These places also should be safe and secure.

We have worked hard to make the University of Kentucky a leader in protecting the health and well-being of our students, faculty, staff, patients, and visitors. Over the last four years, we've invested in technology, programs, and people, all designed to create an even safer campus.

But safety and well-being are a shared responsibility for us all. In the next few weeks you will be asked to complete C.A.T.S., the Campus Attitudes Toward Safety survey. It is a 20-25-minute survey that collects your perceptions of safety, knowledge of resources, and experiences at UK. You will be required to complete it prior to your registration window. Graduating students will need to complete the survey before being able to access their transcripts.

Additionally, first-year students are asked to take Haven, an online violence prevention curriculum that takes about 45 minutes to complete. This program also needs to be completed prior to class registration. Both CATS and Haven are accessible through your myUK account.

This is essential to our ability to create appropriate policies and further strengthen our culture of safety and mutual responsibility. We need to know how safe you feel on campus and what experiences and perceptions inform your views. We need to know, too, what improvements you believe we need to make.

Thanks to students' valuable feedback from last year's C.A.T.S. survey, we have:

- 1. More educational programs about confidential reporting of sexual assault
- 2. More Talk-a-Phone booths on campus as well as improved lighting and camera surveillance
- 3. More sexual assault report training for UK Police
